

#### **Exercise 2: Configuring a custom domain**

#### If you are unable to verify your custom domain, please verify the following:

1. Verify that the **forward lookup zone** has been created correctly. **AVXXXXa.xtremelabs.us**.



2. Make sure that the **TXT** record entered into DNS matches exactly as generated by O365. If O365 sees a value that does not match, it should notify you.


3. Verify the **Text (TXT)** record via **whatsmydns.net**. Type **AVXXXXa.xtremelabs.us** into the text field, set the record to **TXT**, click search. Depending on DNS propagation, it should resolve to the **TXT** record entered into DNS in one or more regions. Make sure the record is correct.

5. Verify the **Name Server (NS)** record via **whatsmydns.net**. Type **AVXXXXa.xtremelabs.us** into the text field, set the record to **NS**, click search. Depending on DNS propagation, it should resolve to **NLS01.AVXXXA.xtremelabs.us** in one or more regions.



 Verify the Start of Authority (SOA) record via whatsmydns.net. Type AVXXXXa.xtremelabs.us into the text field, set the record to SOA, click search. Depending on DNS propagation, it should resolve to NLS01.AVXXXXa.xtremelabs.us in one or more regions. You will also see hostmaster.adatum.com.
